Government have enacted Andhra Pradesh Capital Region Development Authority Act, 2014 (Act.No.11 of 2014) for the purpose of Planning, Execution, Financing and Promoting the Capital Region and Capital City Area for the State of Andhra Pradesh.

- 2. In the G.O 2nd read above, orders were issued, notifying the erstwhile Vijayawada, Guntur, Tenali, Mangalagiri, Urban Development Authority (VGTMUDA) area as Andhra Pradesh Capital Region. In the G.O 3rd read above, orders were issued, notifying area between Vijayawada and Guntur Districts on the Krishna River bank as Capital city. In the G.O 4th read above, orders were issued, constituting the Andhra Pradesh Capital Region Development Authority (APCRDA) under the Chairmanship of the Hon'ble Chief Minister with others as members. In the G.O 5th read above, orders were issued, notifying the Capital City be named as "Amaravati".
- 3. In the G.Os. 6th & 7th read above, orders were issued, establishing Capital City Development and Management Corporation (CCDMC) a Special Purpose Vehicle (SPV) under Companies Act, 2013, for the development, implementation, operation and management of Amaravati, the new Capital City of Andhra Pradesh with the Board of Directors consisting of the Principal Secretary, MA & UD & Chairman of the Executive Committee of APCRDA, as Executive Chairman and 9 Directors.
- 4. In the G.O. 8th read above, orders were issued, appointing Sri Ajay Jain, IAS, Secretary to Government, Energy, Infrastructure & Investment Dept. shall also be the Secretary to Government, (CRDA), MA&UD Department.
- 5. Government, after careful consideration of the matter, hereby reconstitute the Board of Directors in CCDMC is as follows:
